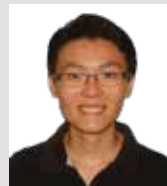

LOCATION MAP

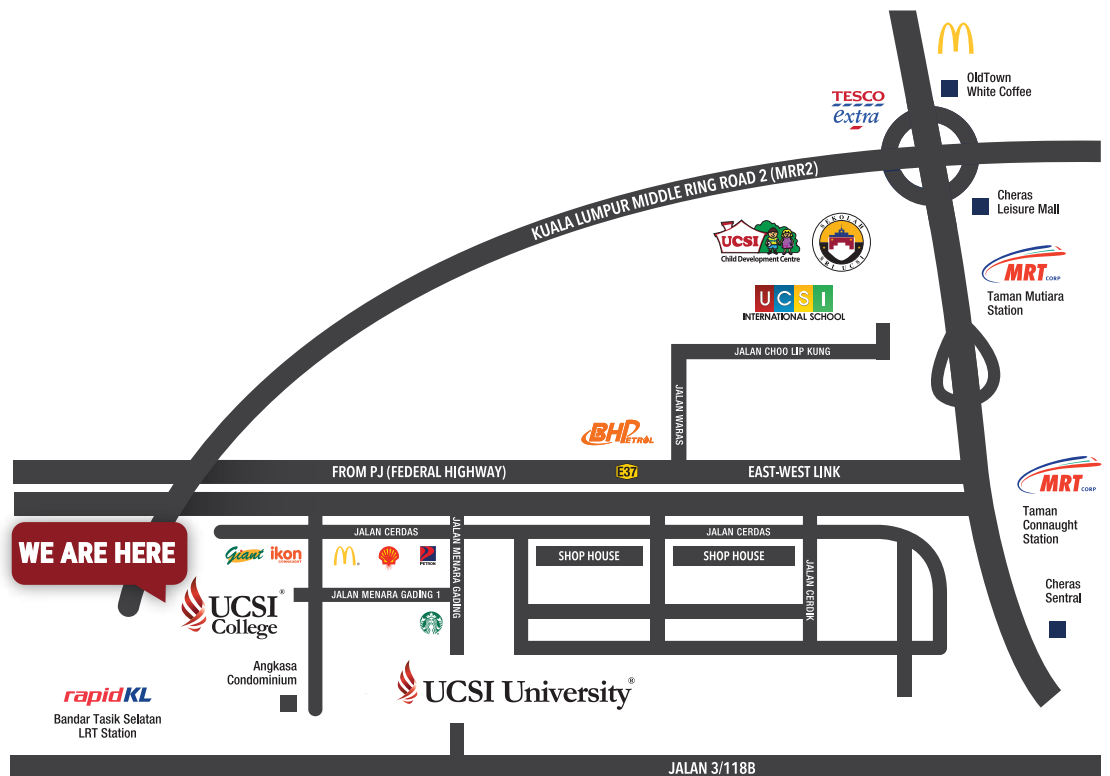
